Trustee McClure reported that he had talked to Paul Summers and offered \$13,000 per acre for seven acres of land north of the cemetery for cemetery expansion. He also asked for right of first refusal to purchase additional land north of the cemetery. To his surprise Paul asked if we would consider land south of the cemetery instead. The consensus was that the township would prefer land north of the cemetery.

Bruce Johnson was present representing the Winnebago Cemetery Board. He is working on obtaining bids for mowing and trimming of the cemetery this coming mowing season.

Trustee Heeren made a motion that the \$1247 received from the sale of the Senior Citizen's Bus be set aside to be used for donations to Vet's Roll. Seconded by Trustee McClure. Roll Call Vote: Aye: Cross, Heeren, McClure and Hodges. Nay: None. Absent: Palm Motion approved 4-0.
