# Winnebago Township Board of Trustees Meeting October 8, 2024 7:30 p.m. Winnebago Township Westfield Facility

Supervisor Hodges called the meeting to order at 7:30 p.m. and then led everyone in the Pledge of Allegiance.

Township officials present were Supervisor, Greg Hodges; Trustees: Dennis Cross, Ray Heeren, Craig McClure and Barry Palm; Road Commissioner, Aaron Rowley; and Clerk Sue Jansen. Assessor Paula Lutzow was absent. Guest present was Craig Campbell.

### **Public Comments**

Mr. Craig Campbell informed the board that the Winnebago County Forest Preserve Commissioners are planning to demolish the Elijah Holt home in Severson Dells, a historic limestone house built in the 1800's. This was one of the first if not the first home built in Winnebago Township. Mr. Holt was one of the first settlers in the township in the 1840's. Mr. Campbell is trying to raise awareness and obtain a one-year moratorium in order to try to get funding to restore the buildings on this historic site. He noted that Winnebago County will be celebrating its 250<sup>th</sup> Centennial in 2026.
